**EUR Class (Institutional Hedged) (ISIN IE000XB8R4W8) (the "Class") is a share class of Polen Capital China Growth Fund (the "Fund") a sub-fund of Polen Capital Investment Funds plc (the "Company")**

This PRIIP is authorised in Ireland and regulated by the Central Bank of Ireland. The PRIIP Manufacturer and the Management Company is Amundi Ireland Limited (the "Manager") which is authorised in Ireland and supervised by the Central Bank of Ireland. Polen Capital HK Limited is the Sub-Investment Manager appointed to the Fund.

### WHAT IS THIS PRODUCT?

The Class is a share class of the Fund which is a sub-fund of the Company, an open-ended umbrella investment company with variable capital and segregated liability between Funds incorporated with limited liability in Ireland under the Companies Act 2014 with registration number 522617 and established as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011 (S.I. No. 352 of 2011), as amended (the "UCITS Regulations").


Subject to the conditions set down in the Prospectus, investors may switch their shares in the Fund or Class for shares in a different class of the Fund or another Fund or Class. Please refer to the section entitled "Conversion of Shares" in the Prospectus and Fund Supplement for further details.

The Prospectus of the Company and the periodic reports are prepared for the entire Company. There is no fixed term for this Fund.

The Fund's objective is to achieve long term growth of capital. The Fund will invest primarily in a focused portfolio of common stock of companies whose shares are listed or traded on Recognised Exchanges globally which have either the predominant part of their, assets in, or their revenues derived from, or substantial business in, the People's Republic of China ("PRC"), Hong Kong and/or Taiwan. The maximum amount of the Fund's investment in developing or Emerging Markets may be up to 100% of its Net Asset Value. The Fund may also invest in global depositary receipts, American depositary receipts, and international depositary receipts where deemed appropriate by the Sub-Investment Manager in order to achieve the investment objective of the Fund. The Sub-Investment Manager will select the stocks and securities which it feels generate real organic revenue growth, provide high returns on invested capital and on equity, have robust free cash flow generation, strong balance sheets and competent shareholder-oriented management teams. The Fund may also hold and maintain ancillary liquid assets, including cash and cash equivalents (such as certificates of deposit) and money market instruments (such as commercial paper, bankers acceptance and other short-term debt securities). The Fund may also invest in and have direct and indirect access to certain eligible China A Shares and China B shares listed on the Shanghai Stock Exchange and Shenzhen Stock Exchange via the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect. The Fund may also invest in China H Shares issued by companies which are incorporated in the PRC and trade on the Hong Kong stock exchange. The Fund may use a limited number of simple derivative instruments for hedging purposes (such as currency swaps and currency forwards). It is not intended that the Fund will be leveraged as a result of its use of derivatives. The Fund is considered to be actively managed in reference to MSCI China All Shares Index (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark. The Shares that you will hold in the Fund are accumulating Shares. This means that income from the Fund's investments will be included in the value of your shares rather than being paid to you as a dividend. You may sell shares in the Fund by submitting an application to the Fund's Administrator before 2 p.m. (Irish time) on any business day and/or such other day or days as may be determined by the Directors of the Company. The Company's depositary is The Bank of New York Mellon SA/NAV, Dublin Branch. ### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended holding period of 5 years is based on the liquidity profile of the Fund as well as the risk profile of the underlying assets. In order to divest/redeem from the Class you can send a completed signed redemption request in the form available from the Administrator in accordance with the provisions of the Supplement for the Fund outlined in the section entitled "Redemption of Shares" prior to 2p.m. (Irish time) on any Business Day (as defined in the Prospectus). and/or such other day or days as may be determined by the Directors of the Company. In order to prevent excessive and disruptive trading practices the Directors may impose a redemption fee not exceeding 3% of the NAV of Shares being redeemed for the benefit of the Fund.
